## People - Fostering a vibrant, inclusive workforce

- Developed a gender balance strategy to address gaps.
- Enhance training focusing on service delivery "Rise and Be Kind".
- Established a Sustainability Committee for strategic oversight, reporting to the Corporate Sustainability Board.



## Nature - Activating climate response

- Achieved zero single-use plastics across all properties, through reusable alternatives. We have conducted an assessment and identified 48 items, where 44 have already been replaced.
- Implementing a waste diversion through recycling, composting and circular economy programs.
- Implementing a comprehensive food waste prevention strategy to halve food waste through guest engagement and production planning.
- Achieved zero food waste in landfill.
- Partnered with sustainability experts to implement best practices and drive continuous improvement.

## Community - Championing inclusive growth

- Forged collaborations with schools, NGOs, and authorities to magnify efforts.
- Conducted materiality assessments to identify key environmental, social and governance impacts.
- Achieve 50% local procurement across food, beverages and consumables.
- Ongoing support to flagship long-term community projects such as Coral Farming, Climate Smart Agriculture, Sunlife Children Cancer Trust and Ile aux Cerfs Biodiversity Regeneration

All these projects demonstrate that we do not work in isolation but engage with our community and serve as active stewards.

Our efforts have been recognised through various awards, including the Best Sustainable Hotel 2023, bestowed upon us by both the Ministry of Tourism and the Ministry of Environment. La Pirogue, Long Beach and Sugar Beach are EarthCheck Silver Certified
